# Letter from the President The Long Game

If you've planted trees recently, you've probably pondered whether you'll ever sit under their shady branches or reap the financial rewards of the forest's first thinning. You may have even Googled, "How long does it take to grow a tree." This is the long game (the tree planting, not the Googling) – what we do now to lay the groundwork for the future, and it's an exercise in planning and action for a cause greater than ourselves.

Private land conservation is a long game. Not only does the act of conserving land take a while, it requires thinking long-term about

your future, your family's future, your legacy, and how that all fits into nature and what you would like this world to look like after you're gone. Aldo Leopold wrote in A Sand County Almanac, "When the land does well for its owner, and the owner does well by his land; when both end

up better by reason of their partnership, we have conservation."

This is what we are after, here at the Conservancy: common-sense conservation initiatives and policies that benefit the land, the landowner and the community. Through our work on conservation easements, transferable development rights, educational forums, keeping working lands in working hands, Greenprinting, and the Junior Conservancy, we are facilitating conservation that is mutually beneficial for the long haul.

Over twenty years ago, when the Conservancy's mission was written by our eight founders, we had no idea where this organization would go or take us, but we knew it was the long game.

Our thought: you can grow by chance or by choice. We knew growing by choice was the wiser of the options, and so we began working toward that goal. Education was always the highest priority, and as we grew in our knowledge, we began the process of conserving and preserving Morgan County's important places and resources with the help of Morgan County landowners for the benefit of the whole Morgan County community.

Today, 5,550 acres of Morgan County's 227,000 acres have been permanently protected by landowners through conservation ease-

ments. That's a chunk, but it's only two and a half percent, and we need to increase the pace of conservation, if we want to control our future and grow by choice. This year, the Conservancy will focus on increasing that pace of conservation, and we invite you to join us in that effort. Let us

not take for granted this idyllic landscape we have inherited. It can be gone in the blink of an eye.

This long game is complex. It is time consuming. But it is filled with joy, and it is an honor to do the work with you. Thank you for your support of the Conservancy. It is because of you and for you that this conservancy, GA's only countywide conservancy, works.

# Revolving Fund At Work: Fairplay School



The Conservancy has stabilized the Fairplay School and hosted two volunteer days. Boy, does it look great! We cut back trees, removed a barn, and returned the interior to its original layout. The non-historic materials which were added during the building's adaptation into a residence in 1953 were removed. What was found underneath was nothing short of spectacular! The original beaded board walls with original green-blue paint color,

outlines of the where the school chalkboards used to hang, as well as pencil scribbles and doodles all over the walls. What amazing finds!

During the first clean-up, twenty-five people spent their Saturday, picking up debris and recyclables, and hauling limbs and leaves to a burn pile. Crepe myrtles were given a muchneeded pruning, and a large planting which was impacting the front facade of the building was removed. After breaking for lunch, board member and former City Manager, David Nunn, led a Q & A session with Dr. Bill Hanson, who attended Fairplay School during his first-grade year in 1937-1938, the last year the school was in operation. Dr. Hanson




happily shared his memories about going to school at Fairplay School and about growing up in Morgan County. It was a treat to hear him talk about it, and we recorded the interview. The second clean-up day focused on the building's interior. Volunteers washed windows and hardwood floors. The building is now ready to sell!

The Conservancy plans to list the property in coming weeks for \$285,000 and is seeking a preservation buyer. Like in the sale of the Foster-Thomason-Miller House, the Conservancy will require the buyer to sign a preservation agreement that will require rehabilitation the building to a certain standard by a certain time. # Land Stewardship Workshop Series III



The Conservancy began 2023 with their third Land Stewardship Workshop Series. Over the course of three Thursdays, attendees learned innovative management techniques to promote healthy wildlife and forests, and how to plan the transition of their farm/estate/assets from one generation to the next. The Chophouse Grille graciously hosted our group of 35+ guests and provided us with impeccable food and service.

During the Wildlife Habitat Management workshop, wildlife biologists Matthew Goode, Kara Nitschke, and Emily Rushton from the Georgia Department of Natural Resources gave insightful presentations on deer, waterfowl and dove, and turkey habitat. The speakers for the Forest Management workshop were Jeff Kastle and Devon Dartnell from the Georgia Forestry Commission, who shared information about

private lands forest management as well as the latest news on emerging timber markets like mass timber, pellet production, and carbon credits.

Last but not least, was the Farm & Estate Transition workshop. Mallory O'Steen of the American Farmland Trust presented on transitioning farms from one generation to the next, Justin Merrifield and Johanna Willingham of the Athens Land Trust provided their insight on conservation incentives in estate planning, and Krisztian Varsa from the Conservation Fund discussed the objectives and goals of the Working Farms Fund.





# Boys & Girls Club Partnership



This school year, members of the Junior Conservancy have helped foster a working relationship with the Madison Boys and Girls Club. In September, the kids met Club Director Sarah Swope and board member David Burbach at the Boys and Girls Club. The Club is located at Historic Pearl High School and currently serves more than 60 members.

The first meeting consisted of introductions to the Club and the area planned for a trail. David Burbach explained to the group that he provides bikes for Boys and Girls Club members to ride during their after-school programming. The bikes are an opportunity for the kids to practice riding bikes in a fun and safe environment. Mr. Burbach expressed his goal to create a trail behind the Club building for students to practice mountain biking skills and expand their recreational area. With this knowledge, the Junior Conservancy got to work. Over the next few months, our students worked to clear the trail using everything from rakes to hand saws!

At the halfway point in the school year, we pivoted to focus on ways to further enhance the trail. The group noticed that a variety of debris littered the trail area and decided to create unique works of art with discarded materials from the trail. Chinese privet and wisteria were identified as invasive species that require removal. Finally, a group brainstormed topics for informational signs to mark spots along the trail.

In February, members from the Conservancy Board and the Boys and Girls Club Board joined our monthly meeting to learn about the kids' progress. The students each spoke about their contributions to the project and how it has impacted them. Then, they led the board members on a walk through the .66 mile trail. Moving



forward, the students will make progress on their project area. This collaboration has strengthened our community partnerships and provided a chance to leave a positive, lasting impact on the community.

# JC Alumni Holiday Party



2022 marked five years of the Junior Conservancy. In this time, more than forty Morgan County high schoolers have participated in the Junior Conservancy program. Each year, students work to learn about and further conservation in Morgan County.

In December, we hosted our first Junior Conservancy alumni event. While our busy alumni were home for the holidays, we invited them to the Seed House for refreshments and conversation. Alumni had the opportunity to hear what current members are doing and share their own accomplishments.
