Letter from the Executive Director

Driven to Grow the Land Trust

Georgia is losing farmland faster than almost any other state. So what's our answer? And with Morgan County facing a threshold—fall below 75,000 acres of farmland and forestland, and the businesses that support agriculture here will start to vanish—what's our plan? Permanent land protection? Farm-friendly zoning? Or maybe a blend of both, guided by solid data.

That data comes from the Critical Mass of Farmland Study and the Cost of Community Services Study. Together, these studies reveal something powerful: Morgan County urgently needs to preserve 20,000 acres of farmland to balance the development coming from every direction. And contrary to public opinion,

farmland contributes far more in taxes than it costs in services, effectively subsidizing other land uses in the county.

With facts on our side, the Conservancy collaborated with the Morgan County Board of Commissioners to

create Georgia's third county-funded farmland protection program. This initiative allows local landowners to tap into millions in federal and state funding now available to buy conservation easements from farmers. The goal? To reach a critical mass of protected farmland that will secure the future of agriculture and the quality of life in our community.

For over 20 years, the Conservancy has worked tirelessly to protect natural, agricultural, and historic resources. We've been turning the flywheel—educating, protecting, educating, protecting—until today, with 6,000 acres secured in conservation easements and a wellinformed community, we stand on the verge of something transformative. Morgan County is ready to establish its own land trust.

The stakes are high, and it's time for us to go further to accelerate the pace of conservation here. We can either meet this moment or be swept away by the sprawl that's consuming rural America. We believe you agree that we can't let Morgan County become just another statistic.

So, we're stepping up. We've expanded our team (see page 3 to meet our new staff), we're applying for Land Trust Accreditation, and we're working with the County to purchase conservation easements from local farmers. All of this on the eve of our 25th anniversary.

What is a Land Trust?

A land trust is a non-profit 501(c)3 organization dedicated to protecting land by holding, monitoring, and defending conservation easements in perpetuity. Landowners still own the land - the land trust simply enforces the easement restrictions to protect the land's conservation values.

The Conservancy was incorporated as a land trust and, for the last 20 years, has been working alongside some of Georgia's most respected easement holders to conserve land.

We've helped landowners identify conservation priorities on their properties, determine how many building envelopes to retain, and connect with the experts—lawyers, appraisers, and land trusts—needed to establish easements.

Acting as the landowner's advocate, we didn't initially see a need to reinvent the process of holding,

monitoring, and defending easements.

But now, times are different. There is a growing demand for conservation easements, both donated and purchased, and our community's trust in the Conservancy has led landowners to request that we hold their easements.

And for landowners to access the funding available for selling conservation easements (development rights) on their land, a land trust is required. With more funding now available for purchasing conservation easements, the Conservancy is committed to securing those dollars for Morgan County landowners, ensuring that our local landscapes are protected for generations to come.

Community Outreach

Meet Senator Brian Strickland

Growing up in Henry County and being the son of one of the last row croppers in that county, Senator Strickland is intimately aware of the pressures on farmland and farmers in Metro Atlanta. Since protecting Georgia's #1 industry, agriculture, is a priority, protecting the farmland that is the asset base of that industry is also a priority.

Sentaor Strickland has been super supportive over the last year of our efforts here in Morgan County to protect a critical mass of farmland. The State's new Farmland Conservation Program is also important to him and will allow the state to leverage federal dollars to fund the protection of Georgia's most important farmland.

On October 3, Senator Strickland joined the Conservancy of a tour of Morgan County farms and met generations of farming families and county leadership to discuss how to protect Morgan County from losing too much farmland.

A big thank you goes out to Bill Kurtz (County Commission Chair), Ben Riden (Bostwick district Commissioner), Tricia and John Bostwick (Mayor of Bostwick), Lucy Ray (Morgan County Extension), and Victoria Prevatt (Conservancy's Director of Philanthropy), who met us for lunch at Morgan's own Market 83 for local beef hamburgers and great conversation. It was a day to feel the momentum.







Growing Capacity

In order to grow the Conservancy's land trust capacity, and in order to conduct the 200+ real estate transactions required to protect an additional 11,000 acres by 2030, the Conservancy's organizational capacity needs to expand. 3rd County-Funded Farmland Protection Program in Georgia

Let's do it. Really do it. Actually protect a critical mass of farmland to retain Morgan County's agricultural industry. Let's keep sprawl at bay. Let's not have terrible traffic. Let us and future generations enjoy this beautiful place and quality of life forever. Some say it's impossible, but we know better. And we're working to prove it.

The County Commissioners are committed, too. They have recently created and funded Georgia's 3rd county-funded farmland protection program designed to leverage federal and state funding to purchase conservation easements (development rights) from farmers.

This program is a great way for farmers to sell development

rights and still retain ownership of their land. Landowners can still farm, forest, hunt, fish, and enjoy the land. They give up the right to subdivide and develop. For ca\$h.

The Agricultural Conservation Easement Program, Agricultural Land Easement (ACEP-ALE), is a federal program that pays farmers for voluntarily giving up some of their development rights, which very well may be one of the keys to protecting Morgan County from the sprawl moving into Morgan County from every direction.

Join us in applauding the Board of Commissioners for taking this very important step and the Malcom and Hunter families for being the first ACEP applicants in Morgan County!

What is ACEP-ALE?

The Agriculture Conservation Easement Program, Agriculture Land Easement (ACEP-ALE), is a voluntary program that pays farmers for voluntarily giving up some of their development rights by executing a conservation easement.

The U.S. Farm Bill program is overseen by the United States Department of Agriculture (USDA) and administered by the Natural Resources Conservation Services (NRCS) with the purpose of paying farmers to protect their privately owned agricultural land from conversion to non-agricultural uses.

The Conservancy has officially submitted its first two ACEP-ALE projects for the fiscal year 2025! If funded by NRCS next year, these easements will protect 168 acres of prime farmland.

ACEP-ALE - Malcom

This past summer, the Malcom Family Farm voluntarily decided to permanently protect 100 acres of their farm to ensure the land remainsing riculture and does not succumb to future development pressure. Located just outside the Bostwick city limits, the Malcom Family Farm is made up of a total of 147.95 acres and

has been owned and operated since the land was purchased in 1930. Today, the farm supports 100 head of cattle and contains some of the



most vital prime agricultural soil in the state. The soil on the farm is used to grow hay, which serves as a secondary food source for cattle when grass becomes scarce during the winter months.

If selected and funded by NRCS, the conservation easement placed on the Malcom Family Farm will only remove development rights – the Malcom's will continue to own the land. The ACEP program will allow the family to continue farming as usual while ensuring the land stays in agriculture, securing a home and livelihood for future generations.

ACEP-ALE - Hunter



Following the Malcom Family Farm's decision, the Hunter Farm began expressing interest in the ACEP program. The Hunter Farm is made up of 68.39 acres and resides in the northern part of Bostwick, adjacent to Jack's Creek Farm, which is also permanently protected by a conservation easement. The Hunter Family decided to place all 68.39 acres into conservation, ensuring that

the farm will never be subdivided and will operate as a farm for years to come. The Hunter Farm currently has 29 head of cattle on the land and is growing hay.


The owner of the Hunter Farm attended our most recent Land Stewardship Workshop Series back in February where we discussed all things ACEP. The ACEP program peaked the landowner's interest, and it has now become a vital tool that he is using to protect the 68.39 acres that has been owned since 2002. Success was achieved this year with the ACEP program here in Morgan County. If NRCS decides to select both projects, a total of 168.39 acres of open space and viable agricultural land will be permanently protected in our county and the landowners who voluntarily gave up their development rights will be compensated for doing so.

Revolving Fund Making an Impact

In 2018, the Conservancy launched a capital campaign to raise funds for the Endangered Properties Revolving Fund. Spurred to action by the need to save a few endangered historic buildings

and thousands of acres of land at risk of subdivision, we raised \$1 million to fund a buy-protect-sell revoving fund.

The Revolving Fund's first project was the Foster-Thomason-Miller House, a success by every measure. The home is now fully restored, and the visibility of the project made a name for the organization locally and statewid. Most important, the Conservancy fully revolved its investment into the next projects.



years, the fund also grew 30% in total assets.

Today, the new owners of the most recent Revolving Fund project, the Fairplay School, are lovingly adapting the historic school into a residence, subject to our preservation agreement, which requires them to rebuild the belltower and restore the front and side facades. Stay tuned for updates on the rehabilitation of one of Morgan County's last remaining historic schoolhouses.
